Hours of Operation

This administrative order is issued in accordance with MCR 8.110(D) and 8.112(B).

A. The Court hours for the Saginaw County Trial Courts are 8:00 a.m. to 5:00 p.m. Monday through Friday.

B. The holidays for the above-referenced courts will coincide with those adopted by the Saginaw County Board of Commissioners. They are as follows:

C. Alternate Days. If one of the holidays listed above should fall on a Sunday, the following Monday shall be observed as a holiday. If one of the holidays listed above should fall on a Saturday, excluding Christmas and New Year's Day, the previous Friday shall be observed as a holiday, except for employees assigned to seven-day operations, who will celebrate the actual date of the holiday. If Christmas Eve or New Year's Eve falls on Saturday or Sunday, the holiday will be observed on Friday. If Christmas Day or New Year's Day falls on Saturday, the holiday will be observed on the previous Friday and Christmas Eve or New Year's Eve will be observed on Thursday the day before.
