1. INSTRUCTIONS

- a. The Construction Documents Issued for Bid dated July 23, 2012 for the referenced project are modified as noted in this Addendum.
- b. All work performed under this document shall be subject to the General Conditions of the Contract and Specifications for similar work in connection with this project.
- c. Verbal statements are not binding on the bids, contracts, or scopes of work. Only authorized written statements issued by the Owner or Architect shall be acknowledged and included as directions for the work.

2. CLARIFICATIONS

- a. The bid due date is changed to Monday August 13, 2012, 2:00pm at the County Controllers Office Purchasing Department.
- b. This project requires Mandatory Walk-through Meeting attendance for bidders. Sub-Contractors are not required to attend the walk-through meeting but it was highly encouraged. A list of the qualified attendees is attached.
- c. It is intended by the Owner and Architect that work on the north end of the ramp be given priority over work in other parts of the ramp. Contractors shall adjust scheduled construction activities to expedite access by those persons attending Spirit Hockey Games. The Owner has scheduled Spirit Hockey Games beginning on Thursday September 27, 2012 at 7:11pm. (A copy of the schedule is attached.) It is required that contractors provide full public access at the north end of the parking ramp during required game times. All construction activity will cease and the areas at the north end of the ramp shall be made safe and available for public use 3 hours before and 3 hours after hockey games are scheduled. **All traffic and parking lane areas throughout the ramp shall be available for public use 3 hours before and 3 hours after the hockey games are scheduled.** Therefore – the north end and driving/parking lanes shall be fully open to the public from 4:00pm – 1:00am minimum for evening games. Construction debris shall be cleaned up and materials shall be organized as directed by the Owner or Architect.
- d. A separate bid and construction document package for the Elevator installation in the South-East elevator shaft has been pre-arranged. The Elevator supplier/installer is hereby assigned to the General Contractor for the Parking Ramp Renovations construction project. The General Contractor shall provide a Performance Bond based on the Elevator Contract in the amount of \$140,000. The cost of this bond is to be included in the Base Bid. Elevator Contractor will abide in insurance coverage as stipulated by the Owner.
