**DENIAL OF PARENTING TIME AND/OR VIOLATION OF
CUSTODY/PARENTING TIME ORDER**

No action can be taken as a result of this form if you do not have a current custody/parenting time order. If you do not have a custody/parenting time order, forms are located in the Friend of the Court lobby to establish or modify custody/parenting time.

- If you have been denied parenting time and/or the other party has violated the custody/parenting time order in effect, please complete the attached form to request enforcement activity by the Friend of the Court.
- You must complete the form in its entirety and return it to the Friend of the Court Office. If you have been denied parenting time, **SPECIFICALLY** allege the date(s) and time(s) you made a physical attempt(s) to pick up the child(ren). If the other party has violated a provision of the custody/parenting time order, you must state the provision which the other party has violated and explain in detail the specifics of the violation.
- The Staff Attorney may choose to send your complaint to Mediation to attempt to resolve the dispute. In this case, you will be notified by mail of the date and time for mediation. **Both** parties must attend Mediation. **If the party requesting enforcement** does not appear for Mediation, the Friend of the Court may not enforce on another request for enforcement until a period of six months has expired. If Mediation is unsuccessful, a Show Cause Hearing may be set.
- The Staff Attorney may choose to skip the Mediation process and schedule a Show Cause Hearing in front of the Judge. You will be notified by mail of the date and time of the hearing. **Both** parties must attend the enforcement hearing. Bring any evidence or witnesses that may support your position.
 - If either party makes a false statement or acts frivolously, he/she may be assessed a minimum fee of \$150.00 by the Court.
