## **NOTICE OF MEETING OF BOARD OF DETERMINATION**


*Notice Is Hereby Given* to you as a person owning lands liable for an assessment or a public corporation subject to assessment, that the Board of Determination will meet on **Wednesday, July 29, 2015 at 7:00 p.m. at the Hemlock High School Auditorium located at 625 N. Hemlock Road, Hemlock, Michigan**, to hear all interested persons and evidence and to determine whether the petition for the maintenance, improvement and consolidation of the Hemlock Tile Drain, Hemlock No. 2 Drain, Hemlock No. 2 Extension Drain, Hemlock No. 3 Drain, Hemlock No. 4 Drain, Pine St. Branch of Hemlock No. 4 Drain, West Hemlock Drain, Kratz Tile Drain, and Pine Ridge Drain to be known as the Hemlock Tile Drain, and the consolidation of the Hemlock Tile Drain Drainage District, Hemlock No. 2 Drain Drainage District, Hemlock No. 2 Extension Drain Drainage District, Hemlock No. 3 Drain Drainage District, Hemlock No. 4 Drain Drainage District, Pine St. Branch of Hemlock No. 4 Drain Drainage District, West Hemlock Drain Drainage District, Kratz Tile Drain Drainage District, and Pine Ridge Drain Drainage District to be known as the Hemlock Tile Drain Drainage District, located and established in Richland Township, Saginaw County, dated May 18, 2015 is necessary and conducive to the public health, convenience or welfare; whether said drain, as consolidated, is necessary for the protection of the public health of the following municipality: Richland Township.

A presentation will be made **July 29, 2015** to the Board of Determination which outlines a brief history of the Drainage Districts, and describes the roles, responsibilities and decisions made by a Board of Determination. The presentation is to provide background for landowners and municipalities in the drainage districts and to facilitate the dissemination of information and the receipt of testimony of landowners in the Drainage Districts. A decision will be made by the Board of Determination after testimony is received.

Proceedings conducted at this public hearing will be subject to the provisions of the Michigan Open Meetings Act and you are further notified that information regarding this meeting may be obtained from the Saginaw County Public Works Commissioners Office located at 111 South Michigan Avenue, Saginaw, Michigan 48602. Persons with disabilities needing accommodations for effective participation in the meeting should contact the County Public Works Commissioner at (989) 790-5258 or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the meeting to request mobility, visual, hearing or other assistance. Minutes of the meeting will be on file in the Saginaw County Public Works Commissioner's office.

*You Are Further Notified*, that persons aggrieved by the decisions of the Board of Determination may seek judicial review in the Circuit Court for the County of Saginaw within ten (10) days of the determination.
