3. **Approval of Minutes**

4. **Report**

- A. Motor Carrier Enforcement Activities.** A copy of the Sheriff's Department MCE activity report was included in the agenda packets members. The report included the number of traffic stops, citations issued, time spent on truck routes and so forth for the last quarter July 09 – September 09.

Department of Public Health.** Steve Alworden distributed activity reports for July - September 2009 to committee members and updated members on SDPH activities including responding to illegal dumping complaints and spoke of upcoming Household Special Waste (HHSW) collection program activities.
