**NOTICE OF MEETING OF BOARD OF DETERMINATION**


*Notice Is Hereby Given* to you as a person owning lands liable for an assessment or a public corporation subject to assessment, that the Board of Determination will meet on **Wednesday, March 23, 2016** at **7:00 p.m.** at the **Dow Event Center, Red Room**, located at **303 Johnson Street, Saginaw, Michigan**, to hear all interested persons and evidence and to determine whether the petition for locating, establishing and constructing of the drain known and designated as the Universal Pump Station Drain, aka: Universal Drain Pumping Station, located and established in Carrollton Township, the City of Zilwaukee, and Saginaw Charter Township, County of Saginaw, dated December 7, 2015, is necessary and conducive to the public health, convenience or welfare; whether said drain is necessary for the protection of the public health of the following municipalities: Carrollton Township, the City of Zilwaukee, and Saginaw Charter Township.

A presentation will be made **Wednesday, March 23, 2016** to the Board of Determination which outlines the Drainage District, and describes the roles, responsibilities and decisions made by a Board of Determination. The presentation is to provide background for landowners and municipalities in the drainage district and to facilitate the dissemination of information and the receipt of testimony of landowners in the Drainage District. A decision will be made by the Board of Determination after testimony is received.

Proceedings conducted at this public hearing will be subject to the provisions of the Michigan Open Meetings Act and you are further notified that information regarding this meeting may be obtained from the Saginaw County Public Works Commissioners Office located at 111 South Michigan Avenue, Saginaw, Michigan 48602.
