INSTRUCTIONS FOR FILING
OBJECTION TO PROPOSED ORDER (FOC 78)

Use this Objection if: you received proposed order regarding custody, parenting time, domicile, or child support from the Friend of the Court and you do not agree with the Order. By filing this objection form, you are requesting a hearing with the Referee.

FILING YOUR OBJECTION :

- 1) Fill out the FOC 78 Objection to Proposed Order (use a separate sheet and attach if you need more room to explain).
- 2) Bring or mail your FOC 78 and four copies of your documents to the Circuit Court Clerk's Office located in the basement of the Courthouse at 111 S. Michigan Ave. Saginaw, MI 48602. If you mail your motion, include a self-addressed stamped envelope for the Clerk to return your copies to you.
- 3) There is no fee to file an objection to a proposed order.
- 4) The Court Clerk will keep the original and one copy and return the remaining copies to you.

SERVING YOUR OBJECTION

- 1) You **MUST** serve the Objection to the other party (and attorney if represented) as soon as possible after filing your motion and at least **5 days before your hearing**. This is done by mailing the Objection and all attachments by first class mail to other party/attorney. If you do not have the other party's address, you can obtain it from the Circuit Court Clerk's office.
- 2) After mailing the Objection, complete the CERTIFICATE OF MAILING section on the bottom of the Objection form.
- 3) **YOU MUST FILE YOUR CERTIFICATE OF MAILING:** Return to the Clerk's office to file two copies of the certificate of mailing. The court clerk will route a copy to the Friend of the Court.

PREPARING FOR YOUR HEARING

- 1) You will get a hearing notice in the mail from the Referee's office. You must attend the hearing on this objection. If you do not appear, the Referee may make a decision without your attendance. Hearings may be conducted by video conferencing (Zoom). Please review the notice of hearing for Zoom instructions.
