COMPUTATION OF TAXES:

TAXABLE VALUE X MILLAGE RATE / 1000 = TAX DOLLARS

EXAMPLE:

TOWNSHIP: KOCHVILLE
 SCHOOL DISTRICT: SAGINAW CITY SCHOOLS
 TAXABLE VALUE: 100,000
 WITH PRINCIPLE RESIDENCE EXEMPTION (PRE): 100,000 X 27.5804 / 1000 = \$2758.04
 WITHOUT PRINCIPLE RESIDENCE EXEMPTION (NON-PRE): 100,000 X 45.5804 / 1000 = \$4,558.04
