ANIMAL CONTROL BUDGET AMENDMENT

Dear Chairman,

Request Section: I ask that the Executive Committee recommend to the Board of Commissioners to increase the 2024 Animal Control budget appropriation up to \$125,000.

<u>Background Information Section:</u> As this is the first full year of operations in the new facility, there were a number of budget items that were unknowns, including staffing levels needed for the increased capacity. The 2024 appropriations were inadequate to cover a number of items including building insurance, building R&M, grounds maintenance and spay/neuter services. The most significant is in the amount budgeted for kennel staff. We have eliminated hiring through a temp. agency to reduce costs and continue to work on efficiencies and better workflows to reduce the number of hours needed.

<u>Financial Information Section:</u> Of the proposed additional appropriation \$55,878.00 would be covered by the budgeted transfer to fund balance (amount that had been budgeted as 'revenue positive'), and up to \$69,122 would be a transfer from donations. There is no impact to the General Fund.

I received the information below from Finance Director Thurston.

[State law, the FY 2024 budget CANNOT be amended after 09/30/2024. The LAST Board meeting of the fiscal year is tomorrow evening with an Executive Committee meeting being held at 4pm.

The Sheriff's Department will need to submit a request to the Board immediately to have the Executive Committee meeting agenda be amended. If that is not possible, then you will need to contact a Commissioner to have an Initiatory Motion be presented for approval at the Board meeting.]

I am asking to be allowed to present to the Executive Committee the following increase to the budget for the 2024 fiscal year. I am requesting an increase to the budget in the amount up to \$25,000.00 from fund balance. We encountered substantial repairs to multiple patrol vehicles. Multiple cars needed suspension repairs, full brake repairs, broken independent axels and others. We were not anticipating this large influx at this time. This total cost we are short is \$9,539.24 I believe we should request an additional \$5,000.00 for any repairs we have not been billed. I am anticipating a possible short fall of near \$5,000.00 for gas and I know there may be a few more oil changes that have not been billed yet.
