The Budget/Audit Committee met and considered Communication No. 6-17-14 from Christina Harrington, Health Officer, Saginaw County Health Department requesting approval of its SCHD Immunization Fee Establishment Policy.

Christina Harrington communicated with the committee that the internal policy will establish procedures the department will follow in establishing fees, for the immunization program, that remain competitive and fiscally responsible as purchasing costs increase, insurance reimbursement fluctuates, and/or new vaccines, biologics, and associated drugs come to market. As part of the county budget process, a cost analysis is performed annually to assess SCHD immunization program fees to align actual costs with fees. Approving this internal policy will allow for time sensitive price adjustments or the offering of new vaccines as applicable to the immunization program.

The Budget/Audit Committee met and considered Communication No. 6-17-20 from Christina Harrington, Health Officer, on behalf of the Saginaw County Opioid Advisory Committee, requesting to enter a contract with Recovery Pathways, LLC, to disperse \$250,000 from the county's opioid settlement fund.

Christina Harrington communicated to the committee that the Opioid Advisory Committee received one application for funding. The initiative, EMS to Pathways Program, will develop and implement a



community paramedic program in partnership with MMR to bridge a gap between emergency medical services (EMS) response and access to substance use disorder (SUD) treatment services. EMS will offer medication assisted treatment and build a streamlined system to directly refer overdose survivors to SUD services. The program will cover medication/treatment during a critical window of service delivery, ensuring patients receive immediate stabilization, critical screening, and partnered handoffs for continuation of SUD services.

We recommend approval to enter into a contract with Recovery Pathways, LLC, to disperse \$250,000 from the county's opioid settlement fund and authorize the proper county officials to adjust the budget accordingly.

The Budget/Audit Committee met and considered Communication No. 6-17-16 from Michael Yelsik, 10th Circuit Court Administrator, requesting approval of a general fund increase and to amend the following budget line items for FY 2025:

- Circuit Court Due Process State Grants expected reimbursement of approximately \$17,000 from Michigan Appellate Assigned Counsel System (MAACS) in June 2025 to partially offset the request
- Circuit Court Due Process Jury Questionnaire processing increase of \$15,000
- Circuit Court Due Process Transcript Costs Appeals increase of \$15,000

- 5.1) **CIVIL/LABOR COUNSEL**, re: Approval of Collective Bargaining Agreement between County of Saginaw and POAM 312 Corrections Officers for the period October 1, 2024 and ending September 30, 2027
- Vice-Chair Little thanked Civil Counsel, Dave Gilbert, and Administrator Hannah for all their hard work in negotiations.
- Vice-Chair Little moved, seconded by Commissioner Matthews, to approve 5.1. Motion carried.
- All Collective Bargaining Agreements have now been settled.

FROM: COMMITTEE ON LABOR RELATIONS -- 5.1

JUNE 17, 2025

Your Labor Relations Committee herewith submits the collective bargaining agreement between the County of Saginaw and POAM 312 - Corrections. The agreement covers the period commencing October 1, 2024 – September 30, 2027. The agreement has been formally ratified by the Union upon acceptance by the County. The financial implications of this agreement will be borne with funds within the existing, respective budgets. A summary of the main provisions is set forth below:

- 1. Duration of CBA 3 years + (October 1, 2024 September 30, 2027)
- 2. Grievance Procedure:
 - Amend the contract to provide that if the grievance does not involve an action or determination by the department head (matter is benefit/salary related), then this matter will be determined by the Administrator's Office (in consultation with the Sheriff), to determine the outcome of the grievance.
- 3. Amend the contract to provide that a Loudermill hearing will be scheduled prior to any suspensions, discharges, or separations of employment, if warranted by the circumstances of the separation.
- 4. Delete the "me too" clauses contained in the contract in Article 19, Sections 25 and 26.
- 5. Amend the contract to reflect that employees will comply with all County policies.
- 6. Delete the references to "fringes" as an adjective for benefits and the "he/she" references in the contract.
- 7. Up to 2% on the DC retirement match. The employee would put money in a 457 account and the County would put money in an existing 401(a) account up to 2%. Match is only available to those employees who qualify for a 401(a) plan.
- 8. Healthcare:
 - Amend the healthcare and retiree healthcare language currently in the contract, per provided language.
 - Continue the high deductible health plan for the 2025 plan year.
 - Healthcare will be implemented as approved by the Union Management Committee and the Board of Commissioners.



9. Wages – Corrections Officers:

Effective first payroll after the last party approves the contract, the parties have agreed to modify the existing wage scale to delete Step 1 from the pay scale and have Step 2 become the new Step 1. Each step in that pay scale will be adjusted to the next higher step accordingly (Step 2 becomes Step 3, etc.) The parties also agree to add a new Step 6, paying a salary of \$65,240.52. (See Exhibit A attached for revised wage scale).

- 3% base wage increase for the second year of the contract, and 3% base wage increase for the third year of the contract and eliminate any contingency on the budget stabilization fund.
- The parties agree to amend the shift premium language to reflect that it covers all hours worked.
- County also proposes a one-time \$500 discretionary signing bonus. Wages Clerical Staff:
- Effective first payroll after the last party approves the contract, 3% base wage increase for each of the three years of the contract, and eliminate any contingency on the budget stabilization fund.
- County also proposes a one-time \$500 discretionary signing bonus.
- 10. Various miscellaneous changes in the contract to include Administrator in place of Controller.
- 11. Delete the language opting out of PA 152 in the last sentence in Article 17, Section 17.
- 12. Amend Article 14 of the contract to provide that employees shall accrue an additional 60 hours of PTO at each step level per year in addition to the amount currently included in the contract.
- 13. Amend Article 14 to provide that any use of PTO over 14 days consecutively requires special approval by the Sheriff.
- 14. Amend Article 14, Section 3B to provide that after January 25 employees may request three (3) "reserved" PTO/vacation times on a first come, first serve basis. (Increase from 2 currently).
- 15. Amend the contract to provide miscellaneous changes converting Non-312 reference for Corrections Officers to 312.
- 16. Amend Article 17, Section 3 to provide that the duration the County will continue to pay its share of the healthcare premium for a maximum of three (3) years will be for permanent disability and death claims.
- 17. Amend the contract to reflect the new Wellness Reimbursement, PTO and Disability Leave policies.
- 18. Delete the DB Plan language with the exception of what is needed to define how to qualify for retiree healthcare in Article 22 and elsewhere in the agreement, and delete the language concerning the elimination of the zero percent contribution for the DC Plan.
- 19. Eliminate Section 1 of Article 26 regarding physical fitness testing.

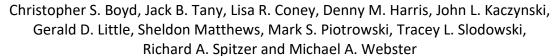

WHEREAS, proceedings have been taken by the Drainage Board for the Cheboyganing Creek Intercounty Drain for improvements to the Cheboyganing Creek Intercounty Drain (the "Project") pursuant to a petition filed with the Saginaw County Public Works Commissioner under the provisions of Chapter 8 of the Drain Code of 1956, as amended (the "Drain Code"); and

WHEREAS, in order to defray the cost of the Project, the Drainage Board has authorized and provided for the issuance by the Cheboyganing Creek Intercounty Drain Drainage District (the "Drainage District") of bonds (the "Bonds") in the aggregate principal amount of not to exceed \$4,200,000, bearing interest at a rate not to exceed 6% per annum, and maturing not later than June 1, 2046, in anticipation of the collection of an equal amount of special assessments against property and public corporations (including the County of Saginaw) in the Counties of Saginaw, Tuscola and Bay in the Drainage District, said special assessments having been duly confirmed as provided in the Drain Code; and

WHEREAS, the Computation of Cost for the Project sets forth an estimated cost of \$4,200,000, to be allocated among the County of Saginaw, the County of Tuscola and the County of Bay as hereinafter provided; and

WHEREAS, 71.38% of the cost of the Project has been apportioned by the Drainage Board to the County of Saginaw, 24.36% of the cost of the Project has been apportioned by the Drainage Board to the County of Tuscola and 4.26% of the cost of the Project has been apportioned by the Drainage Board to the County of Bay; and

WHEREAS, the Drainage Board deems it advisable and necessary to obtain from this Board a resolution consenting to the pledge of the limited tax full faith and credit of the County of Saginaw on the Bonds to the extent of special assessments assessed against property and public corporations in the County of Saginaw; and

WHEREAS, the Project is necessary to protect and preserve the public health and it is in the best interest of the County of Saginaw that the Bonds be sold.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF SAGINAW:

- 1. Pursuant to the authorization provided in Sections 132 and 276 of the Drain Code, the Saginaw County Board of Commissioners, by a majority vote of its members elect, does hereby irrevocably pledge the limited tax full faith and credit of the County of Saginaw for the prompt payment of the principal of and interest on the Bonds to the extent of special assessments against property and public corporations in the County of Saginaw, and does agree that in the event that property owners or public corporations in the County of Saginaw shall fail or neglect to account to the Saginaw County Treasurer for the amount of any such special assessment installment and interest (in anticipation of which the Bonds are issued) when due, then the amount thereof shall be immediately advanced from County of Saginaw funds, and the Saginaw County Treasurer is directed to immediately make such advancement to the extent necessary. The ability of the County of Saginaw to levy taxes to pay its share of the principal of and interest on the Bonds shall be subject to constitutional and statutory limitations on the taxing power of the County.
- 2. In the event that, pursuant to said pledge of full faith and credit, the County of Saginaw advances out of County funds, any part of the principal of and interest due on the Bonds, it shall be the duty of the Saginaw County Treasurer, for and on behalf of the County of Saginaw, to take all actions and proceedings and pursue all remedies permitted or authorized by law for the reimbursement of such sums so paid.



- 3. The Saginaw County Treasurer is hereby authorized, if necessary, to execute a certificate of the County of Saginaw to comply with the continuing disclosure undertaking of the County of Saginaw with respect to the Bonds pursuant to paragraph (b)(5) of SEC Rule 15c2-12 issued under the Securities Exchange Act of 1934, as amended, and amendments to such certificate from time to time in accordance with the terms of such certificate (the certificate and any amendments thereto are collectively referred to herein as the "Continuing Disclosure Certificate"). The County of Saginaw hereby covenants and agrees that it will comply with and carry out all of the provisions of the Continuing Disclosure Certificate, to do all other things necessary for compliance with Rule 15c2-12 issued under the Securities Exchange Act of 1934, as amended, and to do all other things that are necessary to effectuate the sale and delivery of the Bonds.
- 4. This resolution shall become effective only if the Boards of Commissioners of the Counties of Tuscola and Bay each adopt a resolution substantially in the form of this resolution that pledges the limited tax full faith and credit of, respectively, the County of Tuscola and the County of Bay to the payment of the principal of and interest on the Bonds when due to the extent of the respective county's apportioned share of the cost of the Project.
