


Drain Facts

- Where is the Sanderson Drain?
 - See Map Draft Drainage District Boundary
 - Approximately 8,560 feet long (1.6 miles)
 - Watershed area: Approximately 1,139 acres
- What is the drainage district?
 - Lands that contributes storm water to drain
 - Drainage District serves as the special assessment district
 - Sanderson Drain Drainage District includes:
 - Bridgeport Charter Township
 - Saginaw County
 - Landowners Approximately 210 parcels

Drain Facts Continued

- □ Sanderson Drain was established as a county drain in 1981. The drain was cleaned out/constructed via petition in 1984. When it was constructed, there were 2 sections of 8-inch diameter tile installed, with a smaller ditch above the pipe. In these areas, the tile acts as conduit to take smaller flows (low flow), while higher flows are to go through both the pipe and the ditch above the pipe.
- Maintenance completed in November 2014 to remove headwall and fix sink hole at 2760 E Moore Rd.


Drain Facts Continued

- SCPW Maintenance Engineer worked with Road Commission in March/April 2017 – yards along Bell Road north of drain were flooding. SCPW cleaned catch basins over the low flow tubes on the Sanderson Drain. The Road Commission cleaned driveway culverts along Bell Road.
- 2017 & 2019 SCPWC received multiple calls in regards to flooding on properties along Bell Road
- April 2018 SCPWC took bids to clear trees between Bell Road & Moore Road. Low bid was \$26,500 for tree clearing.

Drain Facts Continued

- March 2019 SCPWC received complaints of erosion in the drain near 2760 E Moore. Drain inspection showed evidence that low flow pipe outlet is too high, causing water to work around the pipe and erode the drain banks
- Current petition was filed on June 10, 2019. It was circulated by David Dalton. It was signed by 7 landowners.


Downstream End (Cass River to E Moore Road)



Drain Inspection

- On August 28, 2019 a field review of the Drain was completed as a result of requests for maintenance on the drain. The following was observed:
 - The drain flows through wooded and rural residential areas.
 - □ The portion of the drain downstream of E. Moore Road is mostly a ravine/natural waterway through a wooded corridor, with many trees down in the drain.
 - □ The portion of the drain between Bell Road & E. Moore Road has 2 areas with low flow tubes for approximately 500 feet (out of total 2,045 feet). There are many trees over the pipe. It appears that pipe may be plugged with tree roots and sediment.



Drain Inspection Recap

- There are a lot of trees & brush in the drain, along the entire length.
- It appears that the low flow culverts are plugged with sediment and possibly tree roots. The drain between Bell Road and Moore Road is not functioning properly.
- □ The drain downstream of Moore Road appears to be more like a natural waterway/ravine. It does not appear that there are flooding issues in this area. It is located within the 100-year floodplain of the Cass River.

Summary of Drain Finances

- Spent approximately \$1,500 to repair erosion at 2760 E. Moore Road November 2014.
- Spent approximately \$1,200 for storm sewer cleaning and drain inspection February-March 2017.
- Spent approximately \$550 for tree removal and catch basin cleaning in April – August 2018
- Spent approximately \$550 for inspection and culvert cleaning/maintenance in April – June 2019
- Assessed \$2,500 in 2013 and \$1,000 in 2017 to pay for past inspection/maintenance.
- Drain account currently has approximately -\$2,430.
