State Proposal 20-1

A proposed constitutional amendment to allow money from oil and gas mining on state-owned lands to continue to be collected in state funds for land protection and creation and maintenance of parks, nature areas, and public recreation facilities; and to describe how money in those state funds can be spent.

This proposed constitutional amendment would:

- Allow the State Parks Endowment Fund to continue receiving money from sales of oil and gas from state-owned lands to improve, maintain and purchase land for State parks, and for Fund administration, until its balance reaches \$800,000,000.
- Require subsequent oil and gas revenue from state-owned lands to go into the Natural Resources Trust Fund.
- Require at least 20% of Endowment Fund annual spending go toward State park improvement.
- Require at least 25% of Trust Fund annual spending go toward parks and public recreation areas and at least 25% toward land conservation.

Should this proposal be adopted?

State Proposal 20-2

A proposed constitutional amendment to require a search warrant in order to access a person's electronic data or electronic communications.

- Prohibit unreasonable searches or seizures of a person's electronic data and electronic communications.
- Require a search warrant to access a person's electronic data or electronic communications, under the same conditions currently required for the government to obtain a search warrant to search a person's house or seize a person's things.

“For the purpose of reinforcing public health infrastructure and restoring capacity; to ensure adequate staffing, data analysis and reporting, critical technology needs, broader capacity to provide direct services, adequate facilities, resource readiness for emergencies, and continued communication with health partners, county leaders, and the public, shall the County of Saginaw increase in the limitation of the total amount of general ad-valorem taxes which may be imposed for all purposes upon all taxable real and personal property in Saginaw County, as authorized by Article 9, Section 6 of the Michigan Constitution of 1963, as amended, and levy up to .48 Mill (\$0.48 per \$1,000) of taxable valuation on such property as finally equalized during the years 2020 – 2029, both inclusive, which if approved and levied in its entirety is estimated to raise \$2,435,478 in the first year?”

Frankenmuth Township Road Maintenance Millage Renewal Proposal
Shall the previously voted millage for Frankenmuth Township, Saginaw County Michigan, of two (2) mills (\$2.00 per one thousand dollars), to provide funds for road maintenance and repair within the Township, which exceeds the 15-mill limitation imposed under Article IX, Section 6 of Michigan Constitution on General Ad Valorem Taxes within Frankenmuth Township, be renewed at the two (2) mill rate for an additional four years, 2021 through 2024 inclusive, which levy will raise in the first year of the levy the estimated sum of \$214,450.00?
Richland Township Park Improvement Millage Proposal

Village of Birch Run General Operations Millage Renewal
Shall the previous voted increase in the limitation on general ad valorem taxes in the Village of Birch Run, currently 2.0000 mill (\$2.00 per \$1,000 of taxable value), be renewed and levied for eight years, 2021 through 2028, both inclusive, subject to reduction as provided by law, to finance continued general operations in the Village? This proposed millage is a renewal of previously authorized millage which expires in 2020. It is estimated that a levy of 2.0000 mill would provide revenue of \$134,375 in the first year, if approved and levied. The revenue from this millage will be disbursed to the Village of Birch Run.

Saginaw City School District School Bond Proposal
Shall the School District of the City of Saginaw, County of Saginaw, Michigan, borrow the principal sum of not to exceed Ninety-Nine Million Nine Hundred Fifty Thousand Dollars (\$99,950,000) and issue its general obligation unlimited tax bonds therefor, for the purpose of defraying the cost of: • Constructing, furnishing and equipping new schools, including a new comprehensive high school and a new Handley elementary school, in the School District; • Constructing additions to, equipping, furnishing, reequipping, refurnishing and remodeling School District buildings, including Arthur Hill High School for SASA and the existing Saginaw High School as a middle school, including classroom, auditorium, lighting and climate control improvements; • Acquiring and installing technology infrastructure and equipment; and • Acquiring, improving and developing sites, including outdoor athletic facilities, playgrounds and structures in the School District? The estimated millage to be levied in 2021 to service this issue of bonds is 7.00 mills (\$7.00 per \$1,000 of taxable value) and the estimated simple average annual millage rate required to retire the bonds of this issue is 6.78 mills (\$6.78 per \$1,000 of taxable value). The bonds may be issued in multiple series, payable in the case of each series in not to exceed 30 years from the date of issue of such series. The School District currently has \$43,325,000 of qualified bonds outstanding and \$0 of qualified loans outstanding under the State School Bond Qualification and Loan Program. The School District expects to borrow from the program to pay debt service on these bonds. The estimated total principal amount of such borrowing is \$2,413,426 and the estimated total interest thereon is \$3,557,887. The estimated duration of the millage levy associated with that borrowing is 31 years and the estimated computed millage rate for such levy is 7.00 mills. The estimated computed millage rate may change based on changes in certain circumstances. (Under State law, bond proceeds may not be used to pay teacher or administrator salaries, routine maintenance or repair costs or other school district operating expenses.)
Community College
Delta College Millage Renewal and Restoration
This proposal will permit Delta College to levy 0.50 mill for operating purposes for 8 years. Of the 0.50 mill, 0.4864 represents a renewal of the authorization previously approved by the electors in 2012, which will expire after the 2023 levy and 0.0136 mill represents a restoration of the portion of prior millage authority, which expired in 1999, which was reduced by application of the Headlee Amendment. Shall the limitation on the amount of taxes which may be levied on taxable property in the Delta College district (comprised of the counties of Bay, Midland and Saginaw), be increased by 0.50 mill (\$0.50 per \$1,000 of taxable value) for eight (8) years, from 2024 to 2031 inclusive, as a partial renewal of the 0.4864 mill previously authorized by the electors which expires with the 2023 levy plus new additional millage in the amount of 0.0136 mill, to provide funds for community college purposes? If approved, 0.50 mill would generate an estimated \$5,705,218 for the College when first levied in 2024.
