



STATEMENT OF USER RESPONSIBILITY

Food Truck and Concession Vendors

All users agree to the following (users are the park renter and the food truck operator):

The users assume the entire responsibility and liability for losses, damages, and claims arising out of injury or damage to the user's display, equipment and other property brought onto the premises of the County facility reserved and shall indemnify and hold harmless the County of Saginaw from any and all such losses, damages and claims arising out of such use.

Duration of allowed operation is (1) day (when the park opens to when the park closes). Only one (1) Food Truck allowed per reservation except for special events and up to the discretion of Saginaw County Parks. Fee is \$50 per weekday (Monday-Thursday) and \$100 per weekend day (Friday-Sunday), per Food Truck (no fee if exclusively serving a private event such as a pavilion reservation or other special event). Food Truck, all supplies, and equipment must be cleaned-up and out of the park by closing time.

Food Truck must be parked in the designated location(s) specific to the County Park being reserved.

Food Truck must be self-contained and require no electricity, water, or other service from the Parks Department.

Food Truck vendor must provide liability insurance in the amount of \$1 million per occurrence, listing Saginaw County Parks and Recreation Commission as additionally insured for the day(s) of the event.

Users shall not permit any waste left or damage to park property by action of the Food Truck Vendor, its agents or employees. No shrubs, trees or other vegetation may be damaged, moved or otherwise disturbed as a result of permitted activity. Food Truck Vendor shall repair, replace or restore the permitted area so that it is free from evidence of food truck vendor's use.

It is also the responsibility of the Food Truck Vendor to protect and clean any surface that is unprotected on the reservation day. Should Parks Maintenance staff be required to clean the designated space, the user will be subject to pay a cleaning fee of \$150. **The easiest way to protect the surface from damage is to lay down a protective ground cover, such as cardboard, plastic, or rubber mats. It is best to cover the entire surface of the food truck space.**

Food Truck is subject to all applicable licensing, permitting, and ordinances of the locality and the Saginaw County Health Department.
