



**NOTICE OF REGISTRATION
FOR THE SPECIAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 2, 2021**

To the qualified electors of the Township of Bridgeport

PLEASE TAKE NOTICE that any qualified elector of the Township of Bridgeport who is not already registered, may register to vote at the office of the Township Clerk; the Office of the appropriate County Clerk; a Secretary of State branch office, or other designated state agency. **Michigan residents with a valid Michigan driver's license or State ID can register online using the Michigan Online Voter Registration System at <https://mvlc.sos.state.mi.us/>.** Registration forms can also be obtained at <https://mvlc.sos.state.mi.us/> and mailed to the Township Clerk. Voters who are already registered may update their registration at <https://mvlc.sos.state.mi.us/>.

The last day to register in any manner other than in-person with the local clerk is **Monday, October 18, 2021**.

After this date, anyone who qualifies as an elector may register to vote in-person with proof of residency (MCL 168.492) at the Township Clerk's office (listed below) at the following times:

- Regular business hours (times listed below)
- Saturday, October 30, 2021 from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, November 2, 2021 from 7:00 a.m. to 8:00 p.m.

PLEASE TAKE NOTICE that the qualified electors of the Township of Bridgeport will vote on the following proposal and any other proposals which may appear on the ballot at that time:

Bridgeport Township Municipal Complex Bond Proposal - Shall the Charter Township of Bridgeport, Saginaw County, Michigan, borrow the principal sum of not to exceed Seven Million Six Hundred Fifty-Five Thousand Dollars (\$7,655,000) and issue its general obligation unlimited tax bonds, in one or more series, payable over a period not to exceed twenty-one (21) years from the date of issuance of each series, to provide funds to be used by the Township for the purpose of paying all or part of the cost of acquiring, constructing, furnishing and equipping a new municipal complex, including administrative, police department and fire department facilities, together with related site improvements and appurtenances and attachments? The estimated millage to be levied in 2022 is 2.15 mills (\$2.15 for each \$1,000 of taxable value) and the estimated simple average annual millage rate required to retire the bonds is 1.99 mills (\$1.99 for each \$1,000 of taxable value).
