To the Qualified Electors of Saginaw County

PLEASE TAKE NOTICE all Saginaw County qualified electors have the right to mark a ballot and deposit the ballot in the County Early Vote Center tabulator beginning the second Saturday before an election and ending the Sunday before the election from 9:00 a.m. to 5:00 p.m. and on the Wednesday prior to the election from 11:00 a.m. to 7:00 p.m. The Saginaw County Early Voting Center is located at 618 Cass St. Saginaw, MI 48602 and is open to all qualified electors within Saginaw County.

ALSO TO ELECT THE FOLLOWING NON-PARTISAN OFFICES: Justice of the Supreme Court, Judge of Court of Appeals, Judge of Circuit Court, Judge of Probate Court, Delta College Board of Trustees, Township Library Boards, City Offices, Village Offices, Local School District Board Members, River Rapids District Library Board Members, and any other offices which may appear on the ballot at that time.

PLEASE TAKE NOTICE that the following proposals will appear on the ballot:

City of Saginaw Proposal 1 – Proposal to Amend the City Charter by Adding a New Chapter XIX, Section 1 Entitled, "Back the Blue Public Safety Priority"- Shall the Charter of the City of Saginaw, Michigan be amended by adding a new Chapter XIX, Section 1, to state that "The proposed Back the Blue Public Safety Priority City Charter Amendment, if adopted, would honor, better protect, and provide victim compensation for Fire and Police Officers, Emergency Medical Technicians and other First Responders, and their families."

City of Zilwaukee Water Main Millage Renewal – Shall the City of Zilwaukee, Saginaw County, continue to levy three quarters of a mill (.75 cents per \$1,000.00 dollars) of taxable value of property located in the City of Zilwaukee, Saginaw County, for 5 years, (2025-2029) inclusive in accordance with Article IX, Section 6, of the Michigan Constitution, which will collect in the first year of levy, an estimated revenue of forty thousand two hundred forty one dollars and forty cents (\$40,241.40) Bridgeport-Spaulding Community School District Bond Proposal - Shall Bridgeport-Spaulding Community School District, Saginaw County, Michigan, borrow the sum of not to exceed Twenty-Eight Million Four Hundred Thousand Dollars (\$28,400,000) and issue its general obligation unlimited tax bonds therefor, in one or more series, for the purpose of: erecting, furnishing and equipping an addition to a school building; remodeling, including security improvements to, furnishing and refurnishing, and equipping and re-equipping school buildings; erecting a community recreation building; and equipping, developing, and improving a playground, an athletic field and an athletic facility, driveways, parking areas, and sites? The following is for informational purposes only: The estimated millage that will be levied for the proposed bonds in 2025 is 3.50 mills (\$3.50 on each \$1,000 of taxable valuation). The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is thirty (30) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 2.90 mills (\$2.90 on each \$1,000 of taxable valuation). The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$0. Reese Unity District Library Millage Renewal Proposal - Shall the Reese Unity District Library, Counties of Saginaw and Tuscola, be authorized to levy a millage annually in an amount not to exceed .9965 mills (\$0.9965 per \$1,000 of taxable value), which is a renewal of the millage rate that expires in 2024, against all taxable property within the Reese Unity District Library district for a period of ten (10) years, 2025 to 2034, inclusive, for the purpose of providing funds for all district library purposes authorized by law? The estimate of the revenue the Reese Unity District Library will collect in the first year of levy (2025) if the millage is approved and levied by the District Library is approximately \$286,000.

Your local Clerk's office will be open on Saturday, November 2, 2024, from 8:00 a.m. to 4:00 p.m.

Arrangements for obtaining the instructions in these alternative formats can be made by contacting the city or township clerk in advance of the election. All polling locations are accessible for voters with disabilities.
