The Saginaw County Public Works Commissioner will hold a Day of Review of Drainage District Boundaries and a Day of Review of Apportionment on the above date, time and location for the Eagle Creek Drain.

The Day of Review is for the purpose of reviewing and revising the boundaries of the Drainage District, and also to review the tentative apportionment of benefit for the Drain for each parcel and municipality within the Drainage District. A Day of Review is an opportunity to come into our office and review the Drainage District Boundaries and tentative apportionments with the Public Works Commissioner or a member of his staff. The Public Works Commissioner, engineers, and other staff members will be available to assist individuals throughout the day and make revisions where necessary. Drain Assessments will be collected in the same manner as property taxes. There is no need to schedule an appointment for a specific time on the Day of Review.

A general description of the lands by section number proposed to be added or deleted from the Eagle Creek Drain Drainage Districts as recommended by a licensed professional engineer or surveyor is as follows:

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Public Works Commissioner's Office at the number noted above (voice) or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing or other assistance.

You may appeal the Public Works Commissioner's decision to revise the district boundary to the Saginaw County Circuit Court within ten (10) days and you may appeal the determination of apportionments to the Saginaw County Probate Court within ten (10) days.
