

## NOTICE OF REGISTRATION FOR THE SPECIAL ELECTION TO BE HELD ON TUESDAY, MAY 2, 2023

## To the Qualified Electors of the following school districts: New Lothrop Area Public Schools District and Saginaw Township Community Schools District

PLEASE TAKE NOTICE that any qualified elector of the New Lothrop Area Public Schools District and the Saginaw Township Community Schools District who is not already registered, may register to vote at the office of the Township Clerk; the Office of the appropriate County Clerk; a Secretary of State branch office, or other designated state agency. Michigan residents with a valid Michigan driver's license or State ID can register online using the Michigan Online Voter Registration System at https://mvic.sos.state.mi.us/ Registration forms can also be obtained at <u>https://mvic.sos.state.mi.us/</u> and mailed to the Township Clerk. Voters who are already registered may update their registration at <u>https://mvic.sos.state.mi.us/</u>.

The last day to register in any manner other than in-person with the local clerk is Monday, April 10, 2023.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at their respective Township Clerk's office (listed below) at the following times:

- Regular business hours (times listed below)
- Saturday, April 29, 2023, from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, May 2, 2023, from 7:00 a.m. to 8:00 p.m.

PLEASE TAKE NOTICE that the qualified electors of the New Lothrop Area Public Schools District and the Saginaw Township Community Schools District will vote on the following proposals and any other proposals that may appear on the ballot at that time:

New Lothrop Area Public Schools Sinking Fund Millage Renewal Proposal - This proposal will allow the school district to continue to levy the building and site sinking fund millage that expires with the 2023 tax levy. Shall the currently authorized millage rate of 1.2370 mills (\$1.2370 on each \$1,000 of taxable valuation) which may be assessed against all property in New Lothrop Area Public Schools, Shiawassee, Saginaw and Genesee Counties, Michigan, be renewed for a period of 10 years, 2024 to 2033, inclusive, to continue to provide for a sinking fund for the construction or repair of school buildings, for school security improvements, for the acquisition or upgrading of technology, for the purchase of real estate for sites for school buildings and all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2024 is approximately \$208,862 (this is a renewal of millage that will expire with the 2023 tax levy)?

Saginaw Township Community Schools Bond Proposal - Shall Saginaw Township Community Schools, Saginaw County, Michigan, borrow the sum of not to exceed Two Hundred Forty-Two Million Nine Hundred Forty-Five Thousand Dollars (\$242,945,000) and issue its general obligation unlimited tax bonds therefor, in one or more series, for the purpose of: erecting, furnishing, and equipping additions to school buildings; remodeling, including security improvements, furnishing and refurnishing, and equipping and installing instructional technology and instructional technology equipment for school buildings; erecting a school support building; and developing and improving outdoor learning areas, athletic fields and facilities, driveways, parking areas, and sites? The following is for informational purposes only: The estimated millage that will be levied for the proposed bonds in 2023, under current law, is 5.75 mills (\$5.75 on each \$1,000 of taxable valuation). The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is thirty (30) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 7.55 mills (\$7.55 on each \$1,000 of taxable valuation). The school district expects to borrow from the State School Bond Qualification and Loan Program to pay debt service on these bonds. The estimated total principal amount of that borrowing is 36 years and the estimated computed millage rate for such levy is 7.89 mills. The estimated computed millage rate may change based on changes in certain circumstances. The total amount of qualified bonds currently outstanding is \$15,410,000. The total amount of qualified loans currently outstanding is \$-0-. (Pursuant to State law, expenditure of bond proceeds must be audited and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)
